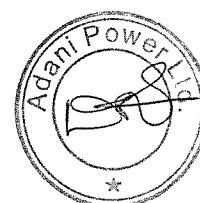

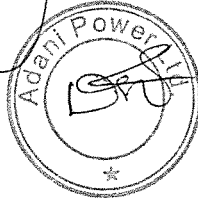
Subsequent to this allotment, the shareholding of the Promoter and Promoter Group has increased to 67.940% of the enhanced paid up equity share capital of the Company.
